

## Popcornopolis and DC LEAGUE OF SUPER-PETS “Movie Night” Sweepstakes

### Official Rules

No Purchase Necessary. A purchase will not increase your chances of winning.

1. **ELIGIBILITY.** The Popcornopolis and DC LEAGUE OF SUPER-PETS “Movie Night” Sweepstakes (“Sweepstakes”) is open to residents of the United States and the District of Columbia who are lawful U.S. residents, are 18 years of age or older and of the age of majority in their state of residence, as of the start date of the Sweepstakes (“Entrants”). The Sweepstakes is sponsored by Barcel USA, LLC Coppel, TX 75019 (“Sponsor”). The movie portion of the prize will be provided by Warner Bros. Home Entertainment Inc. (“Prize Provider”). Employees of Sponsor or Prize Provider, and each of their respective parents and subsidiaries, advertising and promotion agencies, and all other entities participating in the design, promotion, marketing, advertising, administration or fulfillment of the Sweepstakes, and the immediate families of such employees, are ineligible to participate in the Sweepstakes. Void in Puerto Rico, the U.S. Virgin Islands, U.S. military installations in foreign countries, all other U.S. territories and possessions, and wherever else restricted or prohibited by law. 2. **SWEEPSTAKES PERIOD.** The Sweepstakes begins at 9:00 a.m. Pacific Daylight Time (“PDT”) on August 23, 2022 and ends at 11:59 pm. PDT on August 30, 2022 (the “Sweepstakes Period”).
3. **MANDATORY SOCIAL MEDIA DISCLOSURE.** The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook. Entrants are providing information to Sponsor and not to Facebook. The information Entrants provide will only be used for administering the Sweepstakes.
4. **HOW TO ENTER.** There is one (1) way to enter the Sweepstakes;

Via Facebook: To participate via Facebook, Entrants must have or create a non-private Facebook account (“Facebook account”). If Entrants already have a Facebook account, Entrants must sign into their account. If Entrants are not existing members of Facebook, Entrants are required to follow the directions and join Facebook. When Entrants join Facebook, Entrants agree to the Facebook Terms of Service and Privacy Policy. Membership to [Facebook.com](https://www.facebook.com) is free. Using Facebook, during the Sweepstakes Period, Entrants must like the official Popcornopolis Facebook page located at [www.facebook.com/popcornopolis](https://www.facebook.com/popcornopolis) and tag one friend in the comments of the Sweepstakes post on the Popcornopolis Facebook page to receive one (1) Sweepstakes entry.

Limit of one (1) Sweepstakes entry during the Sweepstakes Period. All entries must be received no later than 11:59 pm. PDT on August 30, 2022, according to the computer time on Sponsor’s server. Sponsor is not responsible for late, incomplete, void, corrupted, garbled, misdirected, or otherwise unintelligible entries and for any problems, bugs or malfunctions Entrants may encounter when submitting their entries. Incomplete, garbled, corrupted or otherwise illegible entries are void and will not be accepted. Sponsor reserves the right to disqualify false entries or entries suspected of being false and to disqualify any Entrant it finds to be tampering with the entry

process or the operation of the Sweepstakes or violating these Official Rules. In the event of a dispute as to the identity of a winner, the winner will be deemed to be the authorized account holder of the Facebook account used to enter. If you submit an entry using a mobile device on a wireless service provider's network (as opposed to a Wi-Fi network), your carrier's data rates will apply. You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier.

In all cases, Sponsor makes no ownership claim to Entrant's photos or posts, but by entering the Sweepstakes, Entrant grants Sponsor a nonexclusive, perpetual license to display and repost the image or posts within the social channel in which the image or posts were uploaded.

5. **ODDS.** Odds of winning a prize depend on the number of eligible entries received.
6. **SELECTION AND NOTIFICATION OF SELECTED ENTRANT.** Each Sweepstakes Entry will be entered into a random drawing by a representative of Sponsor from among all eligible entries received during the Sweepstakes Period. The drawing will be held on or about August 31, 2022 ("Drawing Date") to determine five (5) potential winners ("Selected Entrants"). The Selected Entrants will be notified through Entrant's Facebook account used to enter the Sweepstakes within twenty-four (24) hours of Drawing Date ("Notification"). The Selected Entrants will be required to respond (as directed) within seventy-two (72) hours of attempted Notification. A Selected Entrant's failure to respond timely to the Notification may result in forfeiture of the prize, and in such case, Sponsor may randomly select an alternate Selected Entrant from among the remaining eligible entries, up to two (2) times. The Selected Entrants may be sent a declaration of eligibility / liability / publicity release ("Release"). The prize may be forfeited, and in such case, an alternate Selected Entrant may be randomly selected from among the remaining eligible entries if a Selected Entrant: (i) cannot be reached; (ii) does not respond to the Notification in a timely manner as required pursuant to these Official Rules; (iii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iv) cannot accept or receive the prize for any reason. Noncompliance with these Official Rules may result in disqualification and selection of an alternate Selected Entrant. Sponsor may not make multiple attempts to contact a Selected Entrant.

Each entrant acknowledges the language of Section 1542 of the California Civil Code (“Section 1542”), which provides: A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY. Each Entrant hereby expressly waives the protection of Section 1542, or similar protections under any other law. Each Entrant understands and agrees that the released claims or facts in addition to or different from those which are now known or believed by such entrant to exist may hereafter be discovered. It is each Entrant’s intention to waive fully and release all of the claims that such entrant now have against the Releasees, whether known or unknown, suspected or unsuspected, except as to the released claims that cannot lawfully be released.

9. **DISPUTES.** Disputes regarding these Official Rules and/or this Sweepstakes will be governed by the internal laws of the State of California. By entering, Entrant consents to jurisdiction in the federal and state courts of California for the resolution of any and all disputes. Except where prohibited, Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court Central District of California or the appropriate California State Court located in Los Angeles County, California; (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys’ fees; and (c) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. In the event of any conflict with any Sweepstakes details contained in these Official Rules, and Sweepstakes details contained in any promotional materials (including, but not limited to, point of sale, television and

Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules, or to be acting in an unsportsman-like or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Sponsor reserves the right at its sole discretion to terminate the Sweepstakes and, if terminated, at its discretion, select the potential winner(s) in a random drawing from among all eligible, non-suspect entries received prior to action taken. Entrants may not enter with multiple identities or use any automated system, bot or other device or artifice to enter or obtain more than the maximum number of qualified entries. Unclaimed prizes will not be awarded.
11. **PRIVACY.** All personal information collected by Sponsor will be used for administration of the Sweepstakes. In addition, Entrants to the Sweepstakes may be given the option to receive commercial e-mails from the Sponsor; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails. Sponsor uses reasonable commercial efforts to comply with Federal CAN-SPAM guidelines and to supply information to entities that comply with CAN-SPAM guidelines, and Entrants may subsequently opt-out of receiving further emails by following the opt-out instructions contained in the email. 12. **PUBLICITY.** Except where prohibited by law, the Selected Entrant's acceptance of the Prize constitutes permission for Sponsor to use said Selected Entrant's full name, social media handles, photographs, likeness, statements, biographical information, voice, and city and state address for promotional or advertising purposes in connection with the Sweepstakes on a worldwide basis, and in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation, including without limitation on Sponsor and its affiliates' program(s), website(s) and social media page(s).
